PURPOSE:

APPEAL #590 – Todd M. Reed, 6540 Winter St. NE, Louisville, OH 44641 – Parcel #33-02032, zoned R-1 Single Family Residential, is requesting a variance to allow a fence with a height of eight (8) feet for additional privacy & safety instead of six (6) feet as permitted in Section 602.9 <u>Fences, Walls and Hedges</u> of the Nimishillen Township Zoning Resolution.

Chairman Gary Brahler opened tonight's hearing at 7:00 PM and introduced the board, zoning inspector and township secretary. Mr. Brahler swore in everyone in attendance by asking them to swear that the information they were about to present, either in oral or written form, is true and accurate to the best of their knowledge. The people responded by stating, "I do".

Appeal #590: Mr. Reed stepped to the podium and said he constructed the fence himself and apologized to the Board stating he didn't build it 8' on purpose and honestly didn't know there were laws on the height of fences in the township. Where he lived before, there were no rules on fence height. He said there's a rental property next to him. The previous renter had kids that kept climbing his fence. He said it was sort of dilapidated and jagged so he built a new one but said it's mainly for privacy issues and for his dogs.

When asked if he planned to go higher than 8', Mr. Reed said no.

Chairman Brahler asked if there was anyone in attendance to speak in favor of or opposed to Mr. Reed's request. The Board agreed the fence looks nice and neat and they do not see a problem with it.

IN FAVOR:

Earl D. Harden, 6556 Winter Street, stepped to the podium and said he's a new renter and lives beside (east) Mr. Reed. It's his step-mom's property. He said he doesn't mind the fence and has no issues with it. He said it's really nice for Mr. Reed's dogs as well as his own dogs and provides privacy.

OPPOSED:

There was no one in attendance opposed to Mr. Reed's request.

PHONE CALLS / LETTERS:

Chairman Brahler asked if there were any phone calls. Mr. Riggenbach said no one called the office but did receive two letters – one from Melissa Pitts of 6555 Winter Street (north of Mr. Reed) and one from Earl & Kristine Harden of 6540 Winter Street. Both stated they have no issues with the fence height and are in favor of it.

With no more questions from the Board and no further discussion, Chairman Brahler asked for a motion for a ballot vote.
