PURPOSE:

APPEAL #591 – The V.F.W. Post 7490 located at 7459 Columbus Rd. NE, Parcel number 33-08480, zoned B-3 General Business, is requesting a variance for the existing building on the east side to allow a side yard setback of 18' instead of the required 25' as permitted in the Nimishillen Township Zoning Resolution, Section 713.4, Item C, Page 43.

Chairman Gary Brahler opened tonight's hearing at 7:00 PM and introduced the board, zoning inspector and township secretary. Mr. Brahler swore in everyone in attendance by asking them to swear that the information they were about to present, either in oral or written form, is true and accurate to the best of their knowledge. The people responded by stating, "I do".

<u>Robert Nyland, 2207 Avalon NE, Louisville, OH</u> stepped to the podium and stated the V.F.W. Post 7490 wants a division of the property to sell to the Baseball Association. When the building was built back in 2000, it wasn't actually surveyed. The surveyor just drew it because they thought there was enough room. Now, in 2012 and with wanting to divide the property, they are trying to correct it so it will be legal to do a division of property.

When asked who would be responsible to take care of the property, Mr. Nyland said it would be the Hot Stove Baseball Association.

With no one in attendance at tonight's hearing to speak either for or against the variance and with no more questions from the Board, Brahler asked for a motion for a ballot vote.
