<u>Joint water rescue training with Plain Township FD</u>: Chief Peterson reported there will be a joint water rescue training with Plain Twp. Work with Louisville FD to provide assistance at the Constitution Festival: The Chief reported our fire department will be working with the City of Louisville FD to provide assistance at the Constitution Festival on August 18th & 19th.

ROAD DEPARTMENT: (Jack Magee, Superintendent)

<u>Chip & Seal</u>: Jack reported the Chip & Seal project will begin Aug. 15th. The road crew has been working the past couple months getting the roads ready. Hughes will put down the oils and our road crew will put down gravel. The total cost including gravel & oils is \$100,388.25. The following roads, totaling 7.5 miles, will be chipped & sealed: *Hahn from SR44 to Bentler, Shilling from Easton to N. Nickelplate, Schloneger from N. Nickelplate to Meese, N. Nickelplate from RR tracks to Shilling and N. Nickelplate from Schloneger to Paris.* Jack said it's not quite the nine (9) miles he intended this year but said they are moving ahead.

<u>2012 Paving Program</u>: Northstar Asphalt, Inc. from N. Canton will start the week of August 20th doing 3.68 miles of paving at a cost of \$217,320.60. The following roads will be paved: Victory Ave., Clay St., Homeland Ave., Buchtel Ave., Eastland Ave., Peach St., Francesca St., Chester Ave., Birchwood Ave., Mann St., Scott St. and Stoner Ave.
