<u>Discuss – Mosquito Spraying contract with Stark County Health Dept:</u> Trustee Shafer shared that Nimishillen Township will be entering into a contract with Stark County Health Department for Mosquito Spraying. The Board was contacted that the rate will be between \$21and \$26 per mile. The Board is waiting for a final amount before contracting.

Resolution – Road Department pursuant to ORC 5553.045: Trustee Shafer shared the Board received a letter in regards to the on-going controversy issue between Honey Alley and the Carriage House. This matter was discussed in an executive session with the Prosecutor; the Board was asking advice as the Township stands to be sued for not vacating the road. The letter is requesting the Township officials request Stark County Commissioners to go ahead and vacate Honey Alley. This then puts ownership on the Commissioners to vacate or not. Trustee Shafer stated the next meeting that Prosecutor Bickis can attend; they will be discussing this matter further in an executive session. Trustee Shafer stated she'd like a resolution to vacate Honey Alley and proceed with the commissioners to do that.

- 4. Thence, along said right of way a distance of 12 feet to the place of beginning and containing 0.033 acres of land, more or less.
