## **CITIZENS**:

<u>David Pumneo, 7476 Brookside</u> stepped to the podium to follow up on the letter he received dated Dec. 21<sup>st</sup> to Dan Houck, Chief Surveyor at Stark County Engineers, regarding the 'Common Road' that borders the south side of Brookside. (Letter attached)

- <u>'Common Road'</u> Dale said as of this date, there's been no response from the Stark County Engineer's office and Stark County Prosecutor Mike Bickis. Mr. Pumneo said he isn't against Sandy Humphrey using ground-up asphalt on the 'common road'. His complaint is the big pile of ground-up asphalt because it will make it difficult for him to mow in the spring.
- <u>Josh's Tree Service, 5591 Ravenna</u> Mr. Pumneo said owner of Josh's Tree Service, Josh Huprich, fired up the trucks last night around 12:30 AM 1:00 AM and plowed the common road, which woke up him and his wife. Dale said he has not approached Mr. Huprich as of this date. If his trucks are parked in the City of Louisville, we have no say if in the township, there's a Noise Resolution on the books which will not allow him to fire up the trucks in the middle of the night. Mr. Pumneo has not approached Mr. Huprich because he's not approachable at least to him he isn't. Dale is to work on this and Trustee Lynch will call City of Louisville Manager, Tom Ault.
- <u>Proper storage of old cars</u> Mr. Pumneo asked about the procedure is for storage of old cars. Trustee Lynch said all vehicles must have current license plates and must be operable and if not, Dale will handle of the situation.
