On Thursday, October 11, 2012, the Board of Trustees of Nimishillen Township met in regular session at 7:00 PM at the Nimishillen Township Hall located at 4422 Maplegrove NE with the following members present: Trustee Vice President Lou J. Johnson, Trustee Michael L. Lynch and Fiscal Officer Brian Kandel. Trustee President, Lisa R. Shafer, was absent.

Trustee Johnson called the meeting to order at 7:00 PM and led the staff and audience in the Pledge of Allegiance.

GUEST SPEAKERS: Louisville City School Superintendent, David Redd, and Louisville Board of Education member, Dr. Brenda Ramsey-L'Amoreaux, stepped to the podium and asked for the trustees' support on the upcoming 5 year, 5.9 Mill Emergency Operating Levy. If this levy doesn't pass, more cuts will have to be made. After the presentation and discussion between the Township Trustees and City of Louisville board members, Dr. Ramsey-L'Amoreaux asked everyone to consider a 'yes' vote in November and bring pride back to the Louisville Schools, which are attended by township students and city students.

FIRE DEPARTMENT: (Chief Richard Peterson)

Fire Prevention Program with safety trailer: Chief Peterson said the Fire Prevention Program with safety trailer will be at North Nim. School October 15th & 16th starting at 8:30 a.m. Anyone who wants to attend is welcome.

<u>Schedule meeting with Ohio Billing Company</u>: Chief Peterson would like to set up a meeting with Ohio Billing Co. to discuss emergency medical service billing to present our proposal and to listen to Ohio Billing's suggestions. The Chief's proposal would be to bill the resident's insurance company only. The resident would never see a bill nor would they pay anything. The other part is nursing homes where the township could set their own rate. The trustees said they would like to sit in on the meeting. Peterson will let the trustees know the time and date.

<u>CITIZENS</u>: <u>Dave Pumneo, 7476 Brookside</u> stepped to the podium regarding the 'Common Road' that borders the south side of Brookside residents and proposed the township take ownership and divide responsibilities between the neighbors to take care of and maintain the 'common road'. Trustee Lynch explained that Stark County Prosecutor, Mike Bickis, was at the September 27th trustees' meeting and said according to Stark County Auditor's office, it is <u>not</u> a township road; it's a 'common road' or 'private road' and at this time, it is not dedicated to anyone including the township. He said the township can't do anything with it even if they wanted to and that the best scenario would be for the neighbors have the money to hire council to handle it civically. Trustee Lynch said the Board will do whatever they can and asked ZI Riggenbach to contact Attorney Bickis and find out who has the authority to maintain, improve or decide what improvements to make and the use of the 'common road'; find out if the township could be the owner of the road and be the mediator between the neighbors to assign maintenance duties and make sure the road is being maintained by them.</u>
