<u>Funds reduction due to re-evaluation of properties</u>: Trustee Lynch reported we lost a big chunk of money – Nearly \$100,000.00: Approximately \$14,409 will be lost from the general fund, \$47,409 from the fire department and \$37,061 from the road department. Magee commented he thought they took one step forward doing 3 miles of paving and 7 miles of chip & seal and now he'll have to take two steps backwards. However, he stated he was happy that he was able to purchase a new truck and equipment but he and Brian will have to take a closer look at the 2013 budget and work on it closer to January.

An executive session regarding union negotiations was scheduled but due to Trustee Shafer's absence, it was tabled to the next meeting.
