- 1. Kelly McClain with Ohio Insurance Services Agency, Inc. gave the first presentation. They will provide a deductible representative for the township and they will do quality visits. The projected savings would be \$20,641.20 with a higher deductible.
- 2. The second presentation was given by Randy Ecrement with Advanced Insurance Designs, Inc. Mr. Ecrement reported a 9% increase for a renewal of our current plan. He presented several different Aultcare plans with higher deductibles and discussed the Premium Saver Plan.

After hearing both presentations, the Board agreed to review the different plans and make a decision at the January 26, 2012 trustees' meeting.

Discuss – Proposal to provide fire & paramedic services to City of Louisville: Chief Peterson has been talking to Police Chief Turowski, City Manager Tom Ault, Fire Chief John Fetty, Finance Director Gina Lingle regarding a contractual agreement in which Nimishillen Fire Department will provide Fire and Paramedic EMS services to the City of Louisville with a revenue of about \$650,000.00 to the township. This is the same amount they (the city) are paying now. There would be no additional cost to township residents and no increase in their taxes. Discussion followed.
