On Thursday, June 14, 2012, the Board of Trustees of Nimishillen Township met in regular session at 7:00 PM at the Nimishillen Township Hall located at 4422 Maplegrove NE with the following members present: Trustee President Lisa R. Shafer, Vice President Lou J. Johnson and Fiscal Officer Brian Kandel. Trustee Michael L. Lynch was absent.

MOMENT OF SILENCE: Mrs. Shafer asked for a moment of silence.

<u>GUEST SPEAKER</u>: Emily Fernandez, Representative with First Energy Solutions (based in Akron, OH) spoke about electric aggregation and the benefits it provides to townships. This allows elected officials to negotiate a guaranteed savings on residents' electric bills, which would save approx. 10%/month. The biggest benefit is residents wouldn't have to go 'electric' shopping. Ms. Fernandez asked if the township would consider placing it on the November 2012 ballot. The board agreed to wait until all three trustees are present before a decision is made.
