<u>ODOT – Grant for upgrade on signs</u>: Jack reported he received information from ODOT notifying us we are eligible to apply for a grant under the new *Township-wide Systematic Signage Upgrade Program* for intersections, speed limit & curve systematic signs. The top fifty townships in Ohio with a high number of serious crashes from 2007 – 2011 are invited to apply for funding. \$1 million is available statewide with funding capped at \$50,000 for any one township. Funding will be at a 100% share so no local matching funds are required. Jack said he's working on completing the necessary paperwork. The deadline is May 1, 2013.
