On Thursday, April 25, 2013, the Board of Trustees of Nimishillen Township met in regular session at 7:00 PM at the Nimishillen Township Hall located at 4422 Maplegrove NE with the following members present: Trustee Vice President Lou J. Johnson, Trustee Lisa R. Shafer and Fiscal Officer Brian Kandel. Trustee President Mike Lynch was absent.

<u>7:00 PM</u>: Trustee Johnson called the meeting to order, led the staff and audience in the Pledge of Allegiance and asked for a moment of silence.

EXCUSE: Due to illness, Trustee Lynch was excused from tonight's meeting. Chief Peterson was excused as well. He was attending a fire department instructor's conference in Indianapolis.

FIRE DEPARTMENT:

<u>Resolution – Proceed with lighting upgrade</u>: Trustee Shafer explained Chief Peterson is requesting a resolution to proceed with lighting upgrade at all three fire stations and township hall which will make use of a federal energy grant and will save approx. \$3,062 per year in electricity costs. ROI will be 3.8 years. He received the following three proposals.

- o O. D. Miller \$13,740
- o S. J. Lighting \$23,189

CITIZENS:

<u>Kedrick Holbrook, 4721 Fruitland</u> Wanted to know why Mr. Reed on Apple Street has not moved the track hoe as he was asked to do in a letter dated 2/1/13. Riggenbach said Mr. Reed is allowed to have a truck and a trailer with something on the trailer but does not always have to have that piece of equipment on the trailer. Mr. Holbrook was advised the township can't do much more. This is now a civil case between Mr. Holbrook and Mr. Reed. Mr. Holbrook was advised the only other option is to file a civil suit against Mr. Reed. Mr. Holbrook said that's exactly what's going to happen.

Trustee Shafer asked Dale to send a letter to Mr. Reed's new attorney in Strasburg, OH with a copy to Mr. Reed asking if Mr. Reed would consider moving the equipment in question to the other side of the fence giving him a specific area in order to avoid fumes going on to Mr. Holbrook's property.

<u>Joanne Moody</u>, 7018 <u>Pilot Knob</u> Talk about the upcoming school levy stating Louisville has provided her boys a good education, said she's on a fixed income, too, and they have to budget like everyone else and can still make ends meet.

<u>Chuck Wagmiller, 6624 Reno</u> said the 40 MPH speed limit on Reno is too fast. People think they're still on SR62. Magee said he will check with Brian Cole at the Stark County Engineer's to find out when the last speed study was done and said he will also give the Sheriff's Dept. a call. David Scheurer said they tried to get the speed reduced to 25 MPH in the past but the lowest they will go is 35.
