<u>Active 911 Mapping Program</u>: Chief Peterson gave an update on the Active 911 mapping program. The program allows responders to receive incident calls on their mobile phones. They are using the system and are very pleased with it. They have about 12 agencies at this time. The Active911 is extremely fast – the server usually takes < 10 seconds to process, map and page all devices. This cost is \$10 per year per phone.

Fire Dept. Pancake Breakfast: Chief Peterson reported the free community pancake breakfast will be held Sunday, May 12th, from 8 AM to 12 Noon at Fire Station #3 located at 8000 Columbus Road.
