Earlier this summer, there was some pipe work done which interfered with some of the things going on.

The board has been working with some of the property owners to correct the situation. In the meantime, the SCE sent the board a plan with their suggestions as to what the township should/should not do to the ditches in that area. They also provided information and specs for the actual road.

The SCE engineers sent a blueprint with recommendations for the slope of the road in the 6700 block of Reno. The board intends to take this information and send it to at least three (3) contractors for quotes. The weather is not good now so the board isn't sure when this project will get started. The board has not made a decision to move forward; but they have all the information to move forward. Fiscal Officer, Brian Kandel, will be involved regarding funds available whether it be this year or next year. They are talking about different pipe sizing for the ditches as well as the slope of the road.
