"For an in-ground, above-ground, storable pool, the pool or the SIDE OR REAR YARD above grade on which it is located shall be enclosed with a wall or a fence not less than four (4) feet in height. The wall or fence must be maintained in good condition and fitted with a lockable gate."

Discussion was held regarding which of the paragraphs from the swimming section the Board wanted to remove completely.

Discussion was held regarding the discharge/disposal of swimming pool water on a property.
